# <u>People Protecting Poquito Bayou update –</u> <u>Dave Hensley</u>

There's no update on the FDEP/EPA testing.

At the last County Commissioners meeting on May 21st, we are now starting a new front: working with Okaloosa County Commissioners and Growth Management modifying the current land development code to limit clear cutting. May 21st was our first step towards that goal. We need to do research on the effects of clear cutting, what other counties across the country are doing to limit clear cutting and then present this information to the county commissioners. We need concerned citizens to attend future county commissioner meetings to speak on topics related to clear cutting. We need numbers to show up for support and to speak. If you're not comfortable speaking, perhaps your research can help someone present your facts before the county commissioners. This is a team effort!!!

Ms. Ketchel, our County Commissioner, advised me via email that Mr. Elliot Kampert, Okaloosa County Growth Management Director had presented the proposed Land Development Code change affecting clear cutting to some developers and he got stiff opposition. It will be brought before the county commission in mid-July. When we get an advanced copy of the proposed change, we'll forward it to our PPPB concerned citizens email distribution group and our PPPB Facebook webpage.

At the May 21st County Commissioner' meeting, the commissioners approved proceeding with working with Eglin AFB on acquiring multiple "orphan parcels" of land: 'GENERATIONAL OPPORTUNITY': Okaloosa County sets sights on Eglin AFB orphan parcels for development. You may have seen the recent article regarding this. Basically, parcel one is Camp Pinchot, parcel two is East Garnier Creek and parcel five is the former Poquito Bayou MFH area. If my memory serves me correctly, Camp Pinchot and East Garnier Creek were slated for privatized military family housing back in 2005, which was fought by concerned citizens in Longwood. It'll be interesting to see how the public reacts to this news.

We're still trying to get a good snapshot of "Red" the Red Cockaded Woodpecker.

Shelly Hakspiel, who lives at 6 Sharilyn Drive has spotted a gopher tortoise on the property:



We may have a contest on our PPPB FB webpage on the cutest name for this turtle. FDEP representative Kolby Altablet, confirmed that it was indeed a Gopher Tortoise. Quote: "Yes, I can confirm that it is a gopher tortoise and a very striking one at that." Kolby suggested that we document any gopher tortoises or burrows on vacant properties by taking a photo and document our observation to FWC's <u>Gopher Tortoise Sightings (myfwc.com</u>). Shelly Hakspiel did that. I did have a conversation with an individual who was a key member of the Association of Bayou Conservation, the group that successfully stopped Eglin's attempt of privatizing eight hundred acres over in the Camp Pinchot and East Garnier's Creek area back in 2005. He told me that the presence of the gopher tortoise was one of the key reasons the Air Force decided to build elsewhere.

#### POQUITO BAYOU COMMUNITY ASSOCIATION Minutes of the June 3rd, 2024 meeting Leone residence, 30 Poquito, Shalimar

Meeting called to order at 18:01 (by Sean Cramer)

Present: Sean Cramer, Michael Aid, Felicia Murphy, David Boyd, Pat Hollarn, Tricia Flaherty, Mary Ann Leone, and Nance Wendell.

Minutes of the May meeting had been distributed; motion to approve was made by Michael and seconded by Nance, minutes were approved.

<u>Old Business:</u> Mike reported that the Veteran's Memorial Committee action is on hold since the Chair, Jane Fedosky-Hensley, has had other more pressing issues recently. An update is likely at the next meeting. The sign on the monument will also be requiring repair, and a discussion was help on that. The Bylaws committee has continued work on its proposal, and should be ready for the next (August) meeting, and then presented for approval at the October general membership meeting. The Abandoned Homes Committee plans to focus on the two most pressing needs, and determine what violations that can be sent to Code Enforcement.

<u>Treasurer's Report</u>: Treasurer's report for May was presented by Tricia. Income for May was \$1,238.21 and expenses were \$594.26, largely due to the success of the Murphy's Crawfish Boil. Total funds are \$10,132.67 and available funds (not obligated) for budgeted items are \$7,028.45. Motion to approve was made by Michael and seconded by Felicia, report was unanimously approved.

<u>Membership</u>: Felica reported 123 paid members. When people move here, an effort will be made to contact them about membership, and Whitney plans to participate.

<u>BHEV</u>: Candidate night will be held 08 August at BHEV. A separate meeting will be held in the weeks before by those responsible, since the next Board meeting will be only three days prior. A motion was made by Michael and seconded by Pat to authorize up to \$250 for refreshments, and it passed.

Poquito Boat Ramp Park: There is a sinkhole in the ramp park, and the County is aware.

Street & Traffic Safety: There was no update.

Street Directors: There was no update.

<u>Projects Update:</u> Felicia reported that the irrigation system has working, and that may be affected by rainfall and the water table. The owner of the drilling company has promised to address any problems in the near future. There is no update on the storage building project.

<u>Park Update:</u> The County Parks representative Matt Davidson has helped keep our park maintained, and an effort will be made to ensure his successor is encouraged to do the same.

<u>Events</u>: Candidate night will be on 08 August. A shrimp boil or pork butt sale is proposed for Autumn. Don Kreis typically handles the flag in the park, but will be unable for D-Day (06 June), so Michael will fill in and lower the flag to half -staff on 06 June as is customary and appropriate. Pat announced that a friend of hers (Pat Dinges) is willing to speak to groups about the details of Hospice Care, since this is a subject about which many are woefully ignorant until forced into that situation.

<u>Legendary Cove Subdivision</u>: Dave was not present, but sent an update about the Sunset Road development proposal (Legendary Cove) and discussed the recently discovered gopher tortoise, which could result in some delay since they are a protected species. There is no change in the CERCLA process.

<u>Announcements</u>: Newsletter articles for next newsletter due to Bob Davis by the end of the week. Next PBCA board meeting scheduled for 1800 on Monday August 5th at the Flaherty home, 68 Poquito. Meeting adjourned at 18:48 pm. David Boyd, Recording Secretary
