Greetings Neighbors!

I trust everyone had a Happy Easter! The Events Team (led by Felicia Murphy) put together an awesome Easter Egg Hunt on the 30th of March.

The weather has been fabulous lately and I hope everyone has had the opportunity to get out and enjoy. We have continued to try and improve Leo Norred Park and I believe the park is the centerpiece of our neighborhood. Earlier this year, we had a wind storm come through and broke our flag pole. The team jumped to action and replaced it. About the same time, we had an electrical issue with the lights that keep our flag lit and visible at night. Again, the team jumped to action and after some troubleshooting, were able to complete the repair allowing our flag to remain visible at night.



Additionally, we have been working with the Okaloosa County Facilities and Parks Maintenance and they have been very responsive in helping us to improve Leo Norred Park. They provided us new trash cans that are heavier than what we had and hopefully will help keep the bears from making a mess.

Additionally, they have agreed to repair some of the rubber mats on the playground equipment to keep our children safe and able to use the equipment. This is only a temporary fix and they have also agreed to replace the mats that are worn although it may take some time to fit into the budget. Hooray!

While not yet successful we are trying to update the irrigation system. A new well was drilled and pump installed but we still have a water pressure problem. We are working with the contractor to resolve the problem.

Finally, on the negative side, we have had some vandalism at the park recently. We are asking all our neighbors to please keep an eye out and help us eliminate this needless destruction. We have plans to put some new equipment in and destruction of park equipment, generously donated by our community, is simply a shame.

Legendary Cove Subdivision Update - Dave Hensley

On March 25th I received an email from Allison Hankins, Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) Site Manager with the Florida Department of Environmental Protection regarding an update with the document review of the former asphalt plant. ".... We submitted our Pre-CERCLA Screening Assessment report on the APAC Southeast site to EPA and we are now just waiting for their approval. Once the report has been approved by EPA, I will send it over to you. It will also be publicly available on FDEP's website, I will share the link to that with you as well so that you can share it with the community as you see fit." Ms. Hankins was unable to disclose what was in the report. We'll publish the report in a timely manner.

Several months ago, Shirley Godbold brought a cup to a County Commissioner's meeting. She told the audience and the commissioners that this cup was used daily to add water to their coffee maker. Ms. Godbold asked each county commissioner to examine the cup while she spoke. Ms. Ketchel, our county commissioner asked Mr. Michael Hackett, OCWS Director, to investigate this matter.

Several weeks ago, Okaloosa County Water personnel came to Ms. Godbold's residence and took a plethora of water samples inside their home and at the closest fire hydrant. The test results came back last week. We met with Mr. Hackett and some of his staff members to debrief us on the testing results. The four primary inorganic contaminants detected were Fluoride, Sodium, Barium and Chromium. All were below the maximum contamination level (MCL). The four secondary contaminants detected were Chloride, Sulfate, Copper and Total Dissolved Solids (TDS). All were below the maximum contamination level (MCL).

Bottom line: the water is safe. The big question is what's the film in the plastic container? We don't know. The Okaloosa County Water Department has been very cooperative and helpful throughout this process.

We're looking for concerned citizens with high-powered cameras with telephoto lens to capture the Red Cockaded Woodpecker (RCW). If you have the gear and some free time, please contact me.



August Magnolia Ave and Hickory Ave


SYMBOLISM OF VETERAN'S MONUMENT BY JANE FEDOSKY

- TRIANGLE REPRESENTS THE "TRIANGLE PARK" (ITS ORIGINAL NAME). LATER NAMED "LEO NORRED PARK" (A VETERAN, WHO GAVE THE LAND FOR A COUNTY PARK).
- THE POLES REPRESENT INDIVIDUALS WHO SERVED OVER THE YEARS. EACH STANDING STRONG ON THEIR OWN (NO WIRES OR RODS HOLDING THEM UP).
- THE SHAPE OF THE POLES REPRESENT LEO WITH HIS ARMS AROUND HIS FELLOW SOLDIERS. AS IN THE SONG BY BILLY JOEL (GOOD MORNING SAIGON). THE PHRASE IN THE SONG, "WE WILL ALL GO DOWN TOGETHER", SAYS IT ALL.
- THE FLAG CASE IS IN THE HEART OF THE MONUMENT. THE LOCATION SYMBOLIZES WHY THESE VETERANS SERVED. THEY LOVED THEIR COUNTRY AND THE FLAG THAT REPRESENTS IT. SOME EVEN GAVE THEIR LIVES FOR THEIR COUNTRY. THE CASE LIGHTS UP AT NIGHT TO SHOW THESE SOLDIERS. THEY ARE IN OUR HEARTS & MINDS, EVEN IN DARKNESS.
- THE STONES WERE ADDED IN 2022, SYMBOLIZING THE STRENGTH OF OUR SOLDIERS WHILE GUARDING THEIR FORT. THEY ARE A FORCE TO BE RECKONED WITH.
- THE FLOWERS BREATHE BEAUTY AND LIFE INTO THE MONUMENT. THEY ARE A GIFT FROM THE COMMUNITY, THANKING THE VETERANS FOR THEIR SERVICE.

Minutes of the April 1st, 2024 meeting Aid residence, 37 Hickory, Shalimar

Meeting called to order at 18:00 (by Sean Cramer)

Present: Sean Cramer, Dave Hensley, Michael Aid, Felicia Murphy, David Boyd, Pat Hollarn, Tricia Flaherty, Mary Ann Leone, Pam Martin, and Bob Davis.

Minutes of the March meeting had been distributed; motion to approve was made by Mike and seconded by Pam, minutes were approved.

Old Business: Dave reported that the Veteran's Memorial Committee still plans to present two plans at the May meeting. Jane was unable to attend this evening. The Bylaws committee is consolidating proposals to be presented at the June meeting. The Abandoned Homes Committee does not have any news to report, but plans to meet soon to analyze data.

<u>Treasurer's Report</u>: Treasurer's report for March was presented by Tricia, motion to approve by Pat and seconded by Pam, accepted unanimously. Income for March was \$958.81 and expenses were \$397.47. Total funds are \$9,073.20 and available funds (not obligated) for budgeted items are \$5,968.98. Motion to approve was made by Mike and seconded by Felicia, report was approved.

<u>Membership</u>: Pam reported 87 paid members as of the end of March. Nametags at events designating members may be used to encourage membership, especially for residents who participate in events.

<u>BHEV</u>: Candidate night will be held 08 August at BHEV. Bob will invite local candidates and Mary Ann and Felicia will again handle refreshments.

Poquito Boat Ramp Park: Dave reported no update.

Street & Traffic Safety: Bob reported that pothole repairs had been inadequate and drivers are still speeding.

<u>Street Directors:</u> Felicia said that no meeting was held in March, and the next meeting of street directors is a work in progress.

<u>Projects Update:</u> Mike said the foundation was previously laid and the pumphouse was recently constructed by Dan Martin, after which Lendy Edwards and Matt Murphy hooked up the irrigation system. Due to low water pressure from the new well (less than six months), the well company will be contacted. Mike, Sean, and Pam will meet at the park this week to discuss storage shed location

<u>Park Update:</u> Mike and Sean met with County Parks representative Matt Davidson, and the County plans to patch the rubber mats soon, and purchase new playground equipment within the next two years. An MOU will be signed regarding expectations of the Parks Department and PBCA. PBCA plans to continue to cover lighting and electricity.

<u>Events</u>: Felicia reported a successful Easter Celebration on 30 March, with approximately 75 children participating. The cost about \$225 and approximately \$125 was raised during the bake sale, so the event cost was \$100 or less. A Crawfish Boil may yet be possible this Spring (date TBA), and the garage sale will be 20-21 April.

<u>Legendary Cove Subdivision</u>: Dave discussed the Sunset Road development proposal (Legendary Cove, DR Horton) and described the process of CERCLA site manager Allison Hawkins submitting the screening report to the EPA, who will then decide if more testing is required.

Announcements: Newsletter articles for next newsletter due to Bob Davis by Wed April 10th. Next PBCA board meeting scheduled for 1800 on Monday May 6th at the Boyd home, 3A Poquito. Meeting adjourned at 18:56 pm.


